- Copy of the degree certificate of a first degree and proof of a current GMAT (not older than two years)

# GUIDELINES FOR AWARDING FEE REDUCTION / SCHOLARSHIPS

- 1. An EBS fee reduction or scholarship provides financial support for university-related education and training. The scholarship of tuition fee reduction award is intended to give selected future students the opportunity to study at EBS. Applications for tuition fee reduction or a scholarship are, as a rule, to be submitted prior to starting studies. If a fee reduction or scholarship is granted, it includes a percentage reduction of the tuition fees in accordance with the applicable study regulations for the duration of the enrolment at EBS, but at most until the end of the standard period of study of the respective degree programme. A payment in the form of sums of money is not permissible.
- 2. There is no legal entitlement to a scholarship or fee reduction.
- 3. The EBS committee responsible for awarding fee reductions or scholarships examines the complete application for a fee reduction or scholarship submitted by applicants and makes its decision on the basis of the multiple-eye principle.
- 4. Only one fee reduction or scholarship can be granted at a time. A combination of two or more fee reductions or a scholarship is excluded.
- 5. The student who is granted a fee reduction or a scholarship is subject to the obligation to cooperate and to immediately report all circumstances relevant to the granting of the fee reduction or scholarship.
- 6. If the scholarship holder terminates the study programme, the grant received shall be reimbursed to EBS. If the student terminates the study contract without good cause, or if the university terminates the study contract for good cause, the scholarship or fee reduction payments granted up to the time of exmatriculation are due for repayment on this date. If this is unacceptable for the student for personal or financial reasons, the university will, at its equitable discretion, establish a repayment plan for the scholarship or fee reductions awarded, which will weigh up the student's personal and financial capacity as well as the reasons for de-registration, especially according to which sphere they come from, and in particular includes a partial remission for personal hardship cases or instalment payment corresponding to the duration of studies completed.
- 7. In the case of pregnancy and childbirth, a scholarship or fee reduction will continue to be granted in analogy to the protection periods under the Maternity Protection Act.
- 8. In the event of a leave of absence, the decision on the scholarship or fee reductions remains valid, but the grant is suspended for the period of leave of absence.
- 9. The award of a scholarship or fee reduction may also be withdrawn retroactively in whole or in part if it was based on false facts or inaccurate information.
- 10. The grant of a fee reduction will be revoked at the end of the month in which the student terminates or interrupts his or her studies, leaves EBS or changes the degree course, or if the eligibility requirements no longer apply, for whatever reason.
- 11. If the student has received benefits without legal grounds, EBS is entitled to repayment. The repayment entitlement exists irrespective of whether the grant amount has already been used or expended in whole or in part.
- 12. The applicant agrees to the collection, storage and processing of the required personal data for the purpose of selecting and administering the respective scholarship or fee reduction. This may include data on the desired degree, previous education, the subject, the number of semesters/trimesters, the number of grants already received, the award of BAföG grants and data that are absolutely necessary for assessing aptitude within the framework of the selection decision.
- 13. In all other respects, the statutory data protection provisions shall apply.
